PROCLAMATION NO. 141

CREATING AND DESIGNATING CERTAIN PARCELS OF LAND OF THE PRIVATE DOMAIN LOCATED AT FELIX PLAZO SREET, SABANG, NAGA CITY, CAMARINES SUR AS AN INFORMATION TECHNOLOGY PARK PURSUANT TO REPUBLIC ACT NO. 7916, AS AMENDED BY REPUBLIC ACT NO. 8748

Pursuant to the powers vested in me under Republic Act No. 7916, otherwise known as the Special Economic Zone Act of 1995, as amended by Republic Act No. 8748 and upon recommendation of the Board of Directors of the Philippine Economic Zone Authority, I, **BENIGNO S. AQUINO III**, President of the Philippines, do hereby create and designate, subject to the provisions of Republic Act No. 7916 as amended, its Implementing Rules and Regulations, Resolution No. 00-411 dated 29 December 2000 and Resolution No. 10-132 dated 30 March 2010 of the Board of Directors of the Philippine Economic Zone Authority, the fully developed Naga City IT (Cyber) Park as an Information Technology Park located at Felix Plazo Sreet, Sabang, Naga City, Camarines Sur, with an area of **One Hundred Thousand and Nine (100,009) Square Meters**, as defined by the following technical description:
